Origin of the Species

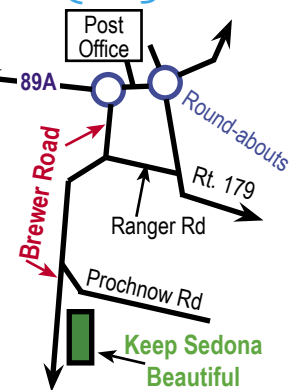

Alternative Cosmology

In the July 2, 2005 issue of *New Scientist*, Marcus Chow stated "A small band of researchers is starting to ask the questions no one is supposed to ask." He was referring to a group calling

non-life is fraught with problems at each of Dawkins' steps. We will outline just a few of the many problems in this first proposed step of polymer formation.

The polymer that Dawkins is referring to is a string of **amino acids**. (If you are thinking maybe Dawkins actually means RNA, consider that RNA *never* occurs anywhere except in a living cell.) Amino acids are the building blocks of life. Amino acids are the basic components of proteins. Proteins must be of exact shape and size in order to accomplish their function. To get the proper shape and size an exact number of amino acids must be connected together. There are many different amino acids. Only 20 of them are used by life. Amino acids come in two varieties called left-hand and right-hand. Proteins use only left-hand amino acids. When amino acids occur naturally, they are half left-hand and half right-hand. Knowing these scientific facts, let's look at three problems with Dawkins argument.

1 Probability. Any polymer of amino acids that could become life has to

be composed 100% of left-hand amino acids. In addition, the order is extremely important in order to result in the proper protein shape and size. If we only consider 20 amino acids, the first amino acid in the polymer can only be one of those 20 AND it must be left-handed. The odds are 1 in 40. The second amino acid must also be the correct one needed for the protein and must be left-handed. Because there are also chain-halting impurities present, the odds are greater than 1 in 40 for the second amino acid. But, we will give the materialist an unfair advantage and say that impurities and non-life amino acids are not present. The odds are now 1 in 1600. Three correct amino acids: 1 in 64,000. You can see than in just a few more amino acids we will be looking at astronomical odds. A small protein has over 80 amino acids.

2 Side Chains. Dawkins' polymer (known as a peptide) of amino acids connect only end to end in life. Here is how the amino acids must line up. Colors indicate the required order of amino acids:  In nature, amino acids will attach in

random order and are more likely to attach to sides rather than ends. The amino acid grouping will actually look like:  There is only one place where they will line up end to end and that is inside a living cell where robots are directed to get the job done.

3 The Law of Chemical Equilibrium. Both illustrations are fanciful illusion. Neither will ever form. When two amino acids form a peptide bond, a water molecule is released. Water molecules tend to break peptide bonds. Indeed, peptide bonds in the presence of water will break apart 3.5 times faster than they form. In order for amino acids to run into each other, they must be in a water solution. This is a *huge* problem. In actual experiments, conducted under ideal conditions with no impurities, about 2%-3% of the amino acids will pair up. Chains of three amino acids amount to about .1%. A chain of four amino acids has never formed in any experiment.

The reality is that Dawkins' required first step cannot happen. Jesus created the first life, the universe, you and me. CRM

Space Blob

The BBC reports that astronomers have discovered a "Lyman-alpha blob" that is 55,000 light years across. This is as large as many present day galaxies.

The problem is that it is 12.9 billion light years distant. This structure was in place just .8 billion years after the big bang. The big bang says this object is much too large to exist at that time. Since scientists tell us there is no doubt the big bang is fact, we propose that this new object does not actually exist.

Oldest Gecko

Scientists are continually pushing back dates for the oldest fossil of *you put just about any critter here*. This time it is the gecko. Previously, the oldest gecko was 70 million years ago. This fossil pushes the gecko back to 110 million years ago. What was found is a lower limb, part of the tail and a foot. The foot of the gecko is the amazing feature. Geckos can walk on ceilings as easily as you and I walk on a floor. The foot of the gecko of 110 million years ago is exactly the same as a contemporary gecko. Because we know mutations happen so plentifully, there should have been some change in the gecko foot, even if very small, over

110 million years. This find supports the idea that the gecko fossil is thousands of years, not millions of years, old.

Enceladus Geysers

New Scientist reports that Enceladus, a moon of Saturn, has active geysers spewing forth water. But Enceladus is so small and far from the sun that it should have frozen solid billions of years ago. Overlooking the obvious conclusion that Enceladus is only thousands of years old, materialist scientists tell us instead that it is ripe for life. Gimme' a break.

Galaxy Magnetic Fields

This report from *New Scientist* informs us that the most distant, and therefore youngest, galaxies have magnetic fields as strong as mature galaxies such as our own Milky Way. The theory *was* that galactic magnetic fields built up slowly as the galaxies spun over billions of years. This report, along with the fact that "mature" galaxies have not wound up so much that the spiral arms disappear into a blob - which would take less than

in Christ in this life only, we are of all men most to be pitied. In other words, if life truly ends at physical death, then we have wasted our time.

Lee Strobel has a law degree from Yale and was the legal columnist for the *Chicago Tribune*. In 1979, Strobel's wife informed him that she had become a Christian. Being an atheist, Strobel was not pleased. His wife changed. Strobel noticed the change and like it. Strobel decided to investigate the claims of the Bible regarding Christ. He spent two years reading and traveling to interview experts. One aspect of that investigation is the claim that Jesus rose from the dead. Strobel came to the conclusion that there are four lines of evidence that prove Jesus rose from the dead. He calls them the 4 E's of the resurrection.

EXECUTION: That Jesus was executed is a fact. Some deny that Jesus even lived, but the many references to his life and execution in the Bible and five sources outside the Bible that tell of His execution make it clear he lived and was hung on a cross. Even atheist experts acknowledge this fact. That Jesus was executed on the cross is undeniable.

EARLY ACCOUNTS: Myths and legends about things such as a hero dying, especially a gruesome death, take a century or more to become thought of as fact. False legends do not come about immediately after the fact because there are too many witnesses who know

different and contradict the story. Only after the witnesses and at least another generation are dead can a legend take hold. There are no longer any witnesses or people who remember hearing the truth. Just **20 years** after the death of Jesus, Paul recites the basic creed of Christians that, according to historians, was firmly established just 8 years after the death of Christ: 1 Corinthians 15: 3-4: *For I delivered to you as of first importance what I also received, that Christ died for our sins according to the Scriptures, and that He was buried, and that He was raised on the third day according to the Scriptures, ...Paul continues with witnesses to the fact... and that He appeared to Cephas, then to the twelve. After that He appeared to more than five hundred brethren at one time, most of whom remain until now, but some have fallen asleep; then He appeared to James, then to all the apostles; and last of all, as to one untimely born, He appeared to me also.*

EMPTY TOMB: This also would be a difficult legend to start until a hundred years later. The fact is that not a single reference can be found in any historical document written in the first century after the death of Jesus that contradicts the claim, which was immediately widespread, that the tomb of Jesus was sealed and guarded. And that it was empty when opened on the third day after the crucifixion. Even the enemies of Jesus never denied the empty tomb in spite of the attempted cover-up story. Nobody had a reason to steal the

critters caught in amber are aquatic, like clams for example. How did they get caught? Scientists at the Natural History Museum in Berlin think they have the answer. body. The Romans wanted Jesus dead and for everyone to know He was dead. The religious leaders wanted Jesus to stay dead. 4 EYE WITNESSES: Jesus appeared to at least 515 people after the resurrection. Surely, not all those who saw Him were glad to see Him. They talked and ate with Jesus. They touched Him. the definition is extremely broad. Or, you could say the definition of species is not very definitive. One author has noted that when a scientist discovers something biologically new, he likes to give it a name, establish the species. It sometimes turns out there is virtually no or very little genetic difference between two species. Eventually, this usually gets straightened out, sometimes not. In the famous battle between the timber industry and the environmentalists, environmentalists insisted the Northern Spotted Owl is a different species than the Southern Spotted Owl. The difference is actually just a matter of whether the owl lives north of central California or south of northern California.

Creationists do not have a problem with how species is defined. The question takes place at a higher level of categorization. The Bible refers to the creation of different **kinds**. The naturalist has built the relationship among species based primarily on physical appearances. Kinds would be defined on the basis of genetic similarity. Since physical appearance was the only possible method for classification in the past, we might expect that the relationship among species is going to change in classification as genetics is used as a basis. For example, genetically, it appears that chickens and peacocks are related.

Natural selection is what Darwin wrote about, though a young earth creationist published on the topic 25 years earlier than Darwin. Creationists do not now, nor have ever in the past, have/had a problem with

natural selection. The problem is that the Darwinist looks to natural selection to create new information. But it cannot. It can only **select** from existing information. (Hence; Natural **Selection**)

Darwin's Finches are a classic explanation of the validity of evolution (I am using evolution in the sense of dinosaurs turning into birds). It doesn't. The Galapagos Island on which the finches live experiences periodic dry spells. When there is a dry year, there is a scarcity of small seeds, but plenty of large seeds. Large seeds take a more powerful beak to break. After a dry year, the finches, in general, have had larger, more powerful beaks. But, every time the smaller seeds came back with the rains, the finch beak returned to an average smaller size... back to normal so to speak. This is what natural selection does. All creatures were created with a genetic code that allows each creature to adapt to changing environments.

What would happen to those finch beaks if the rains didn't return? Eventually, all the finches would have large beaks. After several generations, the genetic code for small beaks would no longer be expressed.

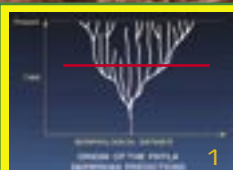
Let's imagine a beetle living on a continent that gets blown by the wind to an island. The wind constantly blows on the island. Each beetle born on the island eventually gets blown off the island and out to sea where it drowns, but not before it has produced offspring. One of those offspring beetles becomes mutated. It does not grow wings. As a result, it does not get blown off the island and therefore produces many offspring. Many of those offspring also have no

wings, having inherited the mutation. After several generations. All beetles born on the island are wingless. Once again, this is natural selection in action.

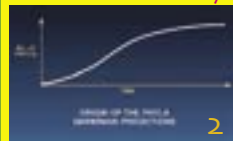
After several hundred years (and generations of beetles) the wind stops blowing. Will the beetles start having offspring with wings again? Possibly, but most likely not. The mutation will probably have become a permanent part of the genetic code with the code for wings lost forever. The beetle is different from the beetles back on the continent now so it is a new species. Has evolution progressed? NO. The genetic information for making wings has been lost. This beetle is not on the way to becoming a wasp. It is now LESS able to adapt to a new environment because it lost a possible survival characteristic.

Climate change happens. It always has and always will. When the local climate changes, each species living in the environment must be able to change. The genetic code allows for those changes, but as characteristics are lost, the ability to survive declines until extinction occurs. That is why the fossil record is a record of extinction. All major phyla appear within what naturalists say is a 3 million year period. This is called the Cambrian Explosion. From there, an occasional new species **suddenly** appears in the rock strata. But 97% of species have disappeared from the strata. At current mutation rates reported by scientists, humans will become extinct in about another 300 generations. The explanation above fits with the data as illustrated in the charts below. CRM

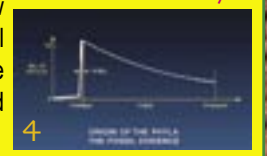
Evolution Theory



Evolution Theory states that life evolved from a single common ancestor. Chart 1 illustrates that as time goes by, the various phyla of life will appear and then species within the phyla. The red line indicates where all phyla have finally appeared. Various species within a phyla would evolve once the phyla came into existence. Chart 2 shows how the number of phyla would increase over time. It is logical and reasonable **IF** you assume there is no God **and** refuse to accept reality of science.



Creation Reality



Creation Theory states that God created all the Kinds (approximately like phyla) and then species would result as the offspring lose information in the genetic code and species become isolated from each other. Species that lose too much information over time to adapt to new environments will become extinct. It is logical and reasonable **IF** you assume God created life **and** accept modern scientific investigation and the data in the fossil record.
